**Alta, Iowa – Nov 2, 2021 —** The Buena Vista County Board of Supervisors has finalized the rezoning of the future site for Platinum Crush, LLC, the new soybean crushing plant that will be built near Alta, Iowa. The rezoning of agricultural land to industrial is a key milestone as the project begins to take shape.

Development partners Mike Kinley and Nick Bowdish joined forces earlier this year to develop Platinum Crush, the second modern soybean processing facility in Iowa.

"We appreciate the supervisors' support and applaud them for their willingness to promote value-added agriculture in Iowa," Bowdish said. "Their leadership is essential to bring a project of this magnitude to fruition."
